Our Mission

Person-to-Person is a volunteer-driven, community-based agency that, through a sharing of goods and talents, **responds to our neighbors** who lack basic human necessities and resources to improve their lives.



Person-to-Person provides **rapid response to client emergencies** as well as access to interconnected services that **support our clients' journey toward self-sufficiency**. These services include practical help, problem solving, advocacy, and education.

We strive to **promote positive change in the lives of our clients** and volunteers, and increased community awareness of needs and problems.

Person-to-Person intends to remain flexible, non-bureaucratic, and reliant on volunteers.



A Message to Our Community

In 2007, Person-to-Person continued to deliver on the promise of its mission – drawing upon the resources of individuals in Darien and surrounding areas to provide basic human necessities and a path to self-sufficiency for our neighbors in need.

As in prior years, the work we accomplished was made possible by our volunteers (*a committed cadre of nearly 3,000 people*) and our contributors (*more than 1,500 individuals and corporations*) who gave so generously of their time, talent and resources to fund Scholarships and Camperships, assist our clients, stock the Food Pantry and donate to the Clothing Center, underwrite waterproofing and refurbishment of our basement facility and more. Their efforts, plus the enduring support of St. Luke's Episcopal Church and its parishioners (*providing us with financial assistance and a home*) and the women of OPUS (*raising funds and generating awareness on our behalf*), combined to allow us to meet the growing demand of those who need a helping hand.

In addition to all of that, the most rewarding aspect of our efforts was our ability to meet the needs of our clients on a daily basis – providing emergency assistance in loans and grants totaling \$268,500, holiday gifts for 2,175 children, layettes for 249 newborns and car seats for 266 children, camperships for 600 children and \$365,000 in scholarships for 147 college students.

In times of economic uncertainty, it is unfortunate but true that our clients often are the first to experience hardship. As of this writing, the marked increase in the need for food, clothing and shelter that we experienced in 2007 has continued into 2008.

Yet we continue our work undaunted – bolstered by the caring and constancy of people like you – as we meet needs and, more important, make a difference. We all understand that a simple, positive change in one person's life serves to enrich the larger community in which we all live.

Meeting the Needs of Those Who Need Us Most

In 2007, we focused on increasing service provision to our clients across all program areas. Though the work we do is measured by the benefits that accrue to our clients, we are pleased with the accomplishments of our volunteers and staff who made all of this possible.

In response to the growing need, we increased the number and amount of Emergency Assistance grants given to our clients.

In the second year of the Stamford Advocate Giving Fund we were able to disperse \$27,223 to clients whose financial need was outside our normal giving parameters and we were selected by the City of Stamford to administer the \$100,000 Flood Relief Assistance Fund.

With the assistance of St. Luke's, we proceeded with installation of the new dry-basement system in the Franklin House and had the opportunity to renovate the Clothing Center and reconfigure the Food Pantry layout early last year.

As a result, the Clothing Center has a new room with infant, toddler, child and youth clothing that features toys for children to play with and take home once the family's shopping is done. Other enhancements include a separate adult clothing room and a more efficient method for distribution of linens. And we were able to increase the number of shoppers to a total of 12 families per hour.

In addition, volunteers led an initiative to better serve the nutritional needs of our clients by increasing the amount of fresh food distributed to families.

Giving Children (and their Parents) a **Summer to Remember**



\$332,000 funded summer camp
for close to 600 elementary and
middle-school children



*Person-to-Person increased the number of students attending middle-school camps and made it possible for children to attend **more than 20 area summer day camps**. We also continued our middle-school collaboration with Domus.*

*And in partnership with the **UCONN University Pals** program, we provided **20 middle-school students** with a four-week on-campus college experience.*

For the families of the children who participated in the Person-to-Person Campership program, **summer camp wasn't a luxury ... it was a necessity.**

The working parents who wanted to be assured that their children are in a **safe and nurturing environment** ... the children of families in crisis for whom camp served as **an oasis of calm and stability** ... the families in search of extended day care options ... the children who needed academic support.

Through the Campership program, children were given the opportunity to **make friends, pursue their interests, learn team-building and life skills** and, most important, to have **a summer filled with fun.**

\$365,000 in scholarships
awarded to 147 students



*Person-to-Person continued to meet **the critical needs of each student** by awarding scholarships that bridged the gap between what the student could earn and save and the amount needed to attend college.*

*And to assist the candidates in this process, we initiated a **Scholarship Application Day** during which students came to P2P and Youth Group members helped them complete their applications.*

Our scholarship recipients included the young woman who was **overwhelmed by the generosity** of people who are strangers to her, the accountant now working in Stamford who **depended upon this scholarship** for completion of his studies, the student from Norwalk who maintained a 3.5 GPA while majoring in pre-med at Virginia State University and so many more.



For some, college is the **achievement of a goal** about which they have dreamed. For others, it is the **beginning of an academic path** that will continue into graduate school. For all, the opportunity for higher education allows them to realize their potential in a meaningful way and positions them to take advantage of limitless opportunities.

I'm a certified Visiting Nurse. I moved to the area from Brooklyn because I wanted better schools for my daughter. P2P helped me with my resume, supported me in my job search and even paid for my driving lessons. Now I have a driver's license, so I can earn more money for my family.



One day a woman came in and she had a little boy with her. I asked if I could help her and she said, "Yes. I'm homeless and I need to speak with somebody here." I was just so taken aback. Who knows what circumstances had led her to this moment. Had she been in another community, she might not have had a place to which she could turn.

For forty years with food, clothing, shelter, practical help, problem solving and education Person-to-Person has had a positive impact on the lives of its clients.

And with the agency's efforts to increase awareness of ongoing problems and continuing need, there is a benefit to the larger community as well.

Working at Person-to-Person allows us to help others and give something back to the community.



While my husband and I were living in a shelter with our three children, P2P placed our two school-age children in a summer day camp. During the school year, they provided assistance with childcare expenses for our youngest. When we found new jobs and an apartment, P2P helped out again with money to cover rent until we received our first paychecks.

I think I actually get more out of this than the clients. For all the things we're blessed with in our lives, being able to give something that you know is so desperately needed is more rewarding than anything.

Financial Highlights (2007 vs. 2006)

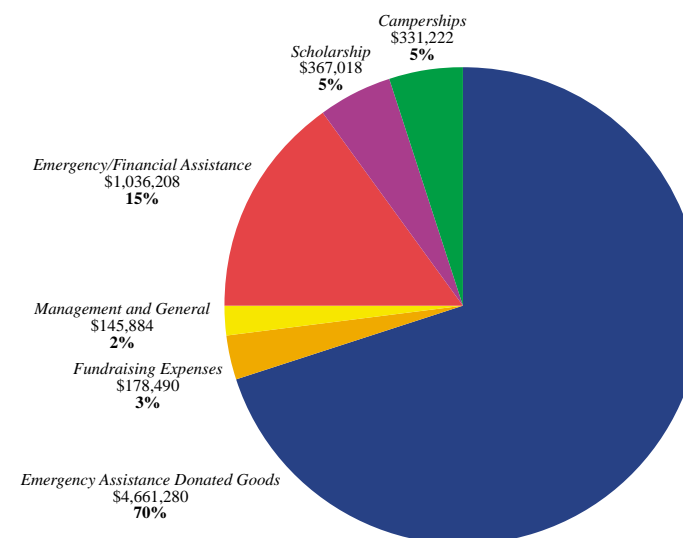
- Person-to-Person continued to experience significant growth in 2007, serving over 20,000 people during the year (+12% vs. 2006)
- Individual Donations increased by almost 10%, with total cash contributions up 4% in 2007 vs. 2006
- Additionally, Unrestricted Investment Income increased by 30% compared to last year due to increased assets and performance earlier in the year
- OPUS contributed \$230,071 after expenses, representing almost 10% of the total cash and other contributions to Person-to-Person in 2007
- Donated Goods for Emergency Assistance increased by 4% to \$4,663,149 in 2007; the Board of Directors also made a strategic commitment to increase Emergency Assistance funding in 2007, up 48% compared to 2006; a combination of generous donors and a successful effort to reduce other expenses helped to offset these increases in Emergency Assistance
- Scholarship Grants rose 20% to \$367,018, recognizing the increased financial need of our students in light of the higher costs in education
- The Janet Evans Endowment Fund (JEEF) was valued at \$2,542,768 at the end of 2007, increasing slightly vs. 2006; expenditures from these funds are limited by charter to no more than 6% of the three-year average of assets per year
